This agenda was posted seven (7) days in advance of the scheduled meeting in compliance with 29 Del. C. § 10004(2). Revision No. 1 was posted on September 22, 2016 to include Substitute 1 to Emergency Ordinance 16-001 which deletes references to freezing any personnel actions other than hiring, reclassifying or otherwise moving political appointees/unclassified service employees into protected county merit positions during a lame duck administration. The substitute is refining an ordinance necessitated by the advent of a lame duck administration that did not occur until the night of September 13th and nonetheless is providing advanced notice of an emergency ordinance that by state law may be introduced and heard at the meeting at which it is introduced.
