ORDINANCE NO. 17-052

**AMEND THE GRANTS BUDGET:
APPROPRIATE \$100,000 FROM THE DELAWARE STATE HOUSING AUTHORITY
TO THE VACANT AND ABANDONED PROPERTY MAINTENANCE GRANT WHICH
WILL BE ADMINISTERED BY THE DEPARTMENT OF LAND USE**

WHEREAS, the County Executive has determined that revenue anticipated to be received is sufficient to cover the increase in the Grants Budget as hereinafter amended.

NOW, THEREFORE, THE COUNTY OF NEW CASTLE HEREBY ORDAINS:

Section 1. The Grants Budget as adopted by Ordinance No. 75-173 is hereby amended by adding the matter on the attached Exhibit "A," which is considered to be underscored in its entirety.

Section 2. This ordinance shall become effective immediately upon its adoption by County Council and approval by the County Executive, or as otherwise provided in 9 Del. C. § 1156.


Section 3. The provisions in this ordinance shall apply retroactively to March 13, 2017.

PROGRAM DESCRIPTION:

Funds received are being provided for the maintenance, demolition and abatement of public safety and health issues of vacant and abandoned properties.

FISCAL NOTE: This ordinance, if approved, would appropriate \$100,000 from the Delaware State Housing Authority to the Vacant and Abandoned Property Maintenance Grant which will be administered by the Department of Land Use.

These funds are being provided to the Department of Land Use by the Delaware State Housing Authority for the maintenance, demolition and abatement of public safety and health issues of vacant and abandoned properties.

The fiscal impact of this ordinance, if approved, would be an increase in the authorized spending authority of the Grants Budget. Since the targeted program completion date for this grant is June 30, 2018, there is no fiscal impact beyond FY2018.
