This schedule represents your permit to use the specified court on the dates and times listed. You should carry a copy of the schedule and your roster to all games. Players must sign NCC Waiver of Liability Forms before participating in the program. All players must be familiar with NCC Rules and Regulations. Proper conduct is expected at all times, and violators will be ejected/suspended if necessary. Teams should arrive early for their games, but **may not enter the facility until after 7:00pm** (M-F). You are responsible for the general care of the facility and must assist with general clean-up of debris before leaving.

- Beverages, food, and smoking are prohibited at each facility.
- Spectator seating may be limited, or not available, in some cases.
- Children under 13 years of age must be accompanied by a non-playing adult.
- **Use of "Libero" is permitted and must have a jersey distinct in color from rest of the team.** The manager is responsible for monitoring any additional rule requirements that apply to the "Libero".
- *In order for a player to qualify for playoffs, players must actively participate on the court **at least three (3) nights during Winter League play.** Managers must maintain their own attendance records throughout the season.* Coordinators will determine the final status on any ineligible players. **Emergency roster additions will be exempt.**

Inclement Weather Procedures

Players can get fastest access to game-day weather related information and cancellations by following the Sports Office on Twitter, @nccdesports, or, in the event of inclement weather, call the Inclement Weather Message Line at (302) 395-5891 after 4:00pm. In the event of inclement weather forecast for later in the day, an updated message may be placed on the recorder at various times as needed.

Payment of Officials

The officials' fees must be paid in cash before the start of each match (including playoffs) at the following rate: \$15 per team per 3-game match, or \$18 per team per 5-game match. Matches must be officiated by volunteers if no league official is present and that substitute should be paid as described above. EXCEPTION: In the event of a forfeit due to insufficient number of players to start a game, the forfeiting team is responsible for payment of both officials' fees. That balance must be paid in full by the next scheduled match. Failure to pay by that time will result in the team being invoiced by NCC for the amount of the officials' fees plus \$5.00 administrative fee.

- All games are played at the Hockessin PAL Center: 7259 Lancaster Pike, Hockessin, DE 19707.
- Please do not enter the facility until 7:00 PM as PAL youth programs will still be using the gymnasium.

- Holiday break is Dec. 22 to Jan. 2.

Digital Roster/Waiver

We will no longer collect paper rosters & waivers. Managers should direct their players to complete the online roster form before the deadline (**Fri, Jan 20**).

QR Code Instructions: Using the camera on your smart phone (or a barcode scanner app) focus on the QR code to the left. A link will appear that directs you to a Google Form. Fill out the individual roster information and click submit.

Players should only complete this roster/waiver form one time (one submission per player, per season). Reminder that players are not eligible to play on multiple teams in the Co-Rec VB league. If managers want a copy of their roster, please contact the Sports Office.
